Up to 15 PCD3.Cxxx module holders can be attached with connection plugs PCD3.K010 and/or cable PCD3.K106 or PCD3.K116 on the PCD3.Mxxx0, (PCD3.M3020/M3060/M3120/M3160 cannot be expanded).


This allows the user to attach a maximum of 64 I/O modules, or 1,023 digital inputs/outputs.




